1. About our Terms

- 1.1. These Terms explain how you may use this website www.squarespaceproperty.com which is provided by us free of charge.
- 1.2. References in these Terms to the Site include the following websites: www.squarespaceproperty.com, www.squarespaceproperty.co.uk and all associated web pages.
- 1.3. You should read these Terms carefully before using the Site.
- 1.4. By accessing or using the Site or otherwise indicating your consent, you agree to be bound by these Terms and the documents referred to in them.
- 1.5. If you do not agree with or accept any of these Terms, you should stop using the Site immediately.

1.7. Definitions

Acceptable use	means the acceptable use, which governs your permitted use of the Site;

Site	Has the meaning given to it in clause 1.1;
Terms	Means these terms and conditions of use as updated from time to time under clause 12;
Unwanted Submission	Has the meaning given to it in clause 6.1;
We	Means Square Space Property, company registration number 10961780 and the registered office of which is at Collingham House, 10-12 Gladstone Road, London, SW19 1QZ (and us or our shall have the same meaning). References to we, our and us in these Terms also includes our group companies from time to time.
You	Means the person accessing or using the Site or its Content (and your shall have the same meaning).

2. **Using the Site**
 - 2.1. The Site is for your *personal and non-commercial* use only.

 - 4.2. Nothing in these Terms grants you any legal rights in the Site other than as necessary to enable you to access the Site. You agree not to adjust to try to circumvent or delete any notices contained on the Site (including any intellectual property notices) and in particular in any digital rights or other security technology embedded or contained within the Site.
5. **Software**
 - 5.1. Software may be made available for you to download in order to help the Site work better. You may only use such software if you agree to be bound by the terms and conditions that apply to such software (this is sometimes known as an 'end user licence agreement' or 'EULA'). 10. **Events beyond our control**

- 10.1. We shall have no liability to you for any breach of these Terms caused by any event or circumstance beyond our reasonable control including, but not limited to, strikes, lock-outs or other industrial disputes; breakdown of systems or network access; or flood, fire, explosion or accident.

11. **Rights of third parties**

- 11.1. No one other than a party to these Terms has any right to enforce any of these Terms.

12. Variation

- 12.1. These Terms are dated 9th July 2020. No changes to these Terms are valid or have any effect unless agreed by us in writing or made in accordance with this clause 12. We reserve the right to vary these Terms from time to time. Our updated Terms will be displayed on the Site and by continuing to use and access the Site following such changes; you agree to be bound by any variation made by us. - 13.1. We will try to resolve any disputes with you quickly and efficiently.

- 13.4. If you want to take court proceedings, the relevant courts of the United Kingdom will have exclusive jurisdiction in relation to these Terms.
